- 30 minutes' maximum discussion time with owner about compliance reports.
- This report is not to be considered a Building Permit. Where any safety barrier alteration works are required, a building permit may be required. It is the owner's legal obligation to ensure an active Building Permit is in place prior to commencing any works.
